## O Scale Central Board of Directors Board Approved Minutes February 10, 2025

Call to Order The meeting was called to order by President Shippy at 8:33 pm ET using Zoom.

Minutes. The January 2025 Minutes were accepted without objection.

Appointment of Director. President Shippy deferred consideration of this item and asked for recommendations.

Officer Reports

President. Shippy referred participants to his written report. He highlighted the formation of an program management group for modular standards to work in coordination with the NMRA. Work continued on layout documentation guidelines.

Treasurer. The Treasurer's Report for January showed a bank balance exceeding \$11,000. Treasurer Norman provided a Profit and Loss statement for all of 2024. Director Peterson asked about rules of thumb for maintaining a reserve. Norman replied that it varies by size and purpose of the organization. Peterson also asked if the dues paid in advance for out years should be separately tracked.

#### Committee Reports

Membership. Director and committee chair Barker's reported 234 members. This total includes 86 members who have not yet renewed for 2025. He will be sending final renewal reminders. (By policy, non-renewals are dropped from the active roles at the end of March.)

Marketing. Director and committee chair Horlacher was absent and did not submit a report.

Website. Advisor Kurzawski reported continued efforts to keep the website up-to-date,

plus adding new features. Official email addresses were updated for all board participants and an index to The Coupler, developed by Peterson, was added. Director Peterson submitted a report on the continued expansion website features and functions.

Social Media. Advisor Shawyer was absent and did not submit a report.

Publications. Advisor Kjelland noted the release of The Coupler #12 and the imminent release of #13. Peterson noted the release of The Drawbar at the beginning of February.

OSC On-line. Neither Past President Vaughn nor Advisor Viggiano were present.

Traction. Advisor Skuchas submitted a written report. He submitted articles for three issues of The Coupler.

Narrow Gauge Outreach. Advisor Ferrell did not make or submit a report.

Club Outreach. Shippy reported that further activity in this project is suspended until after the NMRA National Convention.

Manufacturer's Liaison. Advisor Brennan was not present and did not submit a report.

NMRA SIG. Director Peterson reported extensive OSC activity planned for the NMRA National Convention.

Open Source 3D File Directory. Consideration postponed.

Appoint Coordinator for OSC March Meet Activities. Shippy recounted planning and preparation efforts, but has not named a coordinator.

Confirm OSC Participation. Shippy indicated that his participation in these events might be minimal because of other activities. Appointment of coordinators for each event and approval of funding were postponed.
